Proposition 16	Authorizes California Repeal Proposition 209 Affirmative Action Amendment. RECOMMEND: SUPPORT
Proposition 17	Restores the right to vote to people convicted of felonies who are on parole. RECOMMEND: SUPPORT
Proposition 18	California voting for 17-year-olds RECOMMEND: SUPPORT
Proposition 19	Property Tax Transfers, Exemptions, and Revenue for Wildfire Agencies and Counties Amendment. RECOMMEND: SUPPORT
